The Tulare Joint Union High School District consulted with and sought community and stakeholder input in a variety of ways in the development of the ESSER III Expenditure Plan. In developing the plan, TJUHSD included community input and/or actions from the development of our District's Local Control and Accountability Plan (LCAP). In the development of the LCAP, surveys were sent out to all stakeholders in the Spring of 2021 and presentations were made to stakeholders at ELAC meetings, School-Site Council Meetings, School Advisory Meetings, and DELAC Meetings. Additionally, information was shared and presented to stakeholders during District Budget Advisory Committee meetings multiple times in the Spring of 2021. Members of the district advisory committee include: Administrators, Counselors, Teachers, Classified employees, Students and Parents. In the Fall of 2021, an additional survey was sent out to all stakeholders seeking input on additional supports and needs for students. Feedback was also solicited during district meetings and our district Budget Advisory Committee meeting on October 5, 2021. School sites recruit teachers, classified staff, parents, and students to participate on the Budget Advisory Committee. Prior to each meeting, we utilize Parent Square and emails to send meeting reminders.

Stakeholders provided input through the surveys and participation in the District Budget Advisory Committee meeting on additional interventions, supports, and items for continuous and safe in-person learning. Through this process, our stakeholders clearly indicated that they want our District's plan to include the following interventions for students: tutoring opportunities before school, during lunch, after school, and on Saturdays; additional academic interventions and enrichment opportunities for students; more social-emotional support; academic counseling, college and career counseling; and behavioral supports. Finally, stakeholders want TJUHSD to make sure we continue to provide students and staff with the necessary supplies to provide a safe and continuous learning environment. This includes providing the necessary PPE, cleaning supplies, and masks for band, choir, drama and athletics and appropriate class sizes to be able adequately space students.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
